

# Test Transitions FY25 and FY26

## BEST Plus 2.0, CLAS E Reading, CLAS E Writing, and TABE 11/12 Transitions At-A-Glance



### FY25

- Pre- and Post-Test with BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 as needed.
- FY24 BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 tests administered after April 1, 2024 can be moved forward in FY25 and used as FY25 pre-tests until December 2024.

- Purchase sufficient BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 tests directly from the test publishers for administration in FY25.

#### Budget funds to:

- Purchase BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 tests as needed.
- Pay staff to certify in BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 as needed.
- Pay staff to certify in BEST Plus 3.0, CLAS E Reading Forms C and D, CLAS E Writing Forms C and D, and TABE 13/14 as needed.
- Purchase additional BEST Plus 3.0 Test Administrator Guides (TAG). UMass CEA will provide one BEST Plus 3.0 TAG to each program with certified test administrators when available; programs will need to purchase additional copies with their own funds.

- Staff certify in BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 as needed.
- BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, and TABE 11/12 administrators certify in the new versions of these tests.

- No BEST Plus 2.0 recertification.



### FY26

- Pre- and Post-Test with BEST Plus 3.0, CLAS E Reading Forms C and D, CLAS E Writing Forms C and D, and TABE 13/14 as needed.
- No tests administered with old forms (i.e., FY25 BEST Plus 2.0, CLAS E Reading Forms A and B, CLAS E Writing Forms A and B, TABE 11/12 tests) can be moved forward in FY26.

- Purchase BEST Plus 3.0, CLAS E Reading Forms C and D, CLAS E Writing Forms C and D, and TABE 13/14 tests directly from test publishers for administration in FY26.

#### Budget funds to:

- Purchase BEST Plus 3.0, CLAS E Reading Forms C and D, CLAS E Writing Forms C and D, and TABE 13/14 tests as needed.
- Pay staff to certify in BEST Plus 3.0, CLAS E Reading Forms C and D, CLAS E Writing Forms C and D, and TABE 13/14 as needed.
- Purchase additional BEST Plus 3.0 Test Administrator Guides (TAG).

- Staff certify in BEST Plus 3.0, CLAS E Reading Forms C and D, CLAS E Writing Forms C and D, and TABE 13/14 as needed.
