District summary of needs assessment process does not include Title IVA.

#### **Required Action**

Submit a revised copy of the dated summary of the district's procedure for assessing areas of greatest academic need, including consideration of Title IVA grant-related needs.

#### 1-E Private School Outreach and Programming

**Finding** 

#### Requirements

Private School Outreach and Programming:

District consults with appropriate private school officials regarding services for eligible private school children, maintains written affirmation of consultation, provides equitable services, and evaluates Title I program serving eligible private school students.

#### **Legal Standards**

ESEA §§1117; 8306

#### **Finding Description**

The district did not provide evidence that all potentially eligible private schools received and/or responded to the offer of consultation. The informational letter contained outdated Free and Reduced Price Lunch program eligibility thresholds and inaccurate description of allowable Title IVA grant fund use options.

# **Required Action**

Submit evidence that spring distribution of offers of consultation for school year 2024-25 participation were received by all eligible private schools. In addition, submit a copy of the revised letter with updated Free and Reduced Price Lunch Program eligibility information and revised Title IVA use of funding information.

# 3-B Title I Family/Guardian Engagement

**Finding** 

#### Requirements

District and schools develop jointly with, annually evaluate and update with, and distribute to families/guardians written family/guardian engagement policies and school-family/guardian compacts.

- Family/Guardian engagement policies describe specific rights of families/guardians and the information and meaningful activities developed with families/guardians so the entire community is prepared to participate in student educational growth. Policies must also describe how families/guardians are involved in an annual evaluation of the effectiveness of the family/guardian engagement in improving academic achievement.
- School-family/guardian compacts are agreements between the entire school and the home (families/guardians) that describe the responsibilities of each party, including the student, if desired.

#### **Legal Standards**

ESEA §§1111-1112; §§1114-1116

#### **Finding Description**

Submitted district family engagement policy does not contain all required components and school policies were not submitted. There is no evidence of distribution of policies or opportunity for family input on them.

# **Required Action**

Submit a revised, dated copy of the district's and each Title I school's family engagement policy that contains all required components. In addition, provide evidence that policies were distributed, and families had opportunity to provide input on them.

# Requirements

Submit a written summary of the 2023-24 school year Title I, Part D program evaluation, including indicators of impact on student achievement, strengths and weaknesses of the program, and subsequent program changes. Submit a detailed plan for how you will carry out the 2024-25 Title I, part D program evaluation, including the timeline of steps involved, data collected and analyzed to gauge impact, individuals responsible for each step, and stakeholders consulted. Participate in targeted technical assistance on program evaluation as required by the Federal Grant Programs office.

Submit a detailed plan for how you will carry out the 2024-25 Title IIA program evaluation, including the timeline of steps involved, data collected and analyzed to gauge impact, individuals responsible for each step, and stakeholders consulted. Include in your plan how you will collaborate with participating private schools to evaluate services. Participate in targeted technical assistance on program evaluation as required by the Federal Grant Programs office.

Submit a detailed plan for how you will carry out the 2024-25 Title IVA program evaluation, including the timeline of steps involved, data collected and analyzed to gauge impact, individuals responsible for each step, and stakeholders consulted. Include in your plan how you will collaborate with participating private schools to evaluate services.
