Finding

Required Action

Submit evidence that the 2024 report card letter with the right to know information has been distributed to families/guardians at each Title I school in the district. These letters should have the correct date and list the specific URL where the report card can be found for each school. Submit evidence that the 2023 and 2024 district report cards are posted on the website. Please note that for the 2024 report card, the letter will need to be delivered to families/guardians and the website updated by the end of February 2025. 3-C Title I Family/Guardian Outreach and Involvement

Finding

Requirements

Schools conduct meetings at least annually to inform participating families/guardians of students about Title I programs. District and its schools develop materials and implement training/meeting time for Title I families/guardians to understand and collaborate on:

- The state's academic content standards and state student academic achievement standards;
- State and local academic assessments, including alternative assessments;
- The family/guardian engagement requirements of section 1116; and

4-B Title I Schoolwide Programs

Finding

Requirements

Schoolwide Programs:

If applicable, district develops comprehensive schoolwide program plans with involvement of community, individuals to be served, and relevant staff. Schoolwide plans are evaluated annually and must be:

- Developed with the involvement of parents and other members of the community to be served and individuals who will carry out the plan, including teachers, principals, other school leaders, paraprofessionals, and administrators of programs included;
- Regularly monitored and revised as necessary based on student needs;
- Developed in coordination and integration with other Federal, State, and local services, resources, and programs;
- Based on a comprehensive needs assessment of the entire school that takes into account information on the academic achievement of children in relation to the challenging State academic standards, particularly those children who are failing or most at risk of failing to meet those standards;
- Inclusive of description of the strategies the school will use to:

Legal Standards

Finding Description

Requirements

Allocating funds: Activities supported with Title II, Part A funds must collectively address the needs of all subgroups of students in the district. In addition, schools identified for support and improvement, and schools with the highest percentage of low-income students are prioritized for participation in activities funded by Title II, Part A.

Legal Standards

ESEA § 2103(b)(2) and § 2103(b)(2)(C)

Finding Description

The district professional development plan does not articulate the collective needs of all subgroups in the district. The plan does not identify how low-income students are prioritized.

Required Action

Submit a procedure that includes a description of the process for prioritizing schools to receive Title IIA funds.

12-A Title IVA Distribution of Funds

Finding

Requirements

Districts are required to prioritize the distribution of Title IVA funds to schools with the greatest needs, have the highest percentages or numbers of children in poverty, are identified for support and improvement, are implementing targeted support and improvement plans, or are identified as a persistently dangerous public elementary school or secondary school under section 8532.

Legal Standards

ESEA §4106(e)(2)(A)

Finding Description

The district did not submit an explanation of how schools are prioritized to receive Title IV funds.

Required Action

Submit copy of written policy for distributing Title IVA funds that aligns with the statutory requirements: "...to schools with the greatest needs, have the highest percentages or numbers of children in poverty, are identified for support and improvement."
